Dear Mr. Messerly,

We are writing in response to your violation letters dated 7/22/08 & 7/30/08 regarding Meadowlook Subdivision WWTP, Rodney Village WWTP and Tara Estates Subdivision WWTP. We, along with our staff, review the WWTP reports sent to you every month and are aware of non-compliance. We have been working diligently to find the source of I&I into our collection systems beginning April 2008 when the County hired Dreier & Maller, Inc. at a cost of \$7,190.00 (paid invoices attached) to clean and camera the collection lines at both Meadowlook & Rodney Village II systems. The findings and repairs were reported to you by email on 7/18/08 (see attached copy of the email). The repairs for Meadowlook and Rodney Village II were completed at a cost of \$9,708.04.

Our staff feels the repairs at Meadowlook and Rodney will solve the problems at those WWTP's. We have had significant rainfall since the repairs were made and neither plant was washed out or affected in a detrimental way. In regard to the Tara Estates WWTP, that plant will be eliminated very soon with the construction of the Kanauga/Addison sewer project, which should go to bid around November 2008. The Rodney Village II plant will be eliminated with the Green Phase I project, if OEPA approves our request to change the recent findings and orders to a larger project with more time to implement. The Meadowlook WWTP will be eliminated with the Green

Phase 2 project, which is in the planning stages now with hopes for construction shortly after Kanauga/Addison and Green Phase I are completed.

Given enough time, Gallia County has a plan in place to remedy these problems. Thanks for working with us to find solutions.
